
- *Paint - paint all exterior surfaces of building where the paint is peeling, chipping, flaking, or faded.*
- *Grass/Weeds - cut and maintain grass and weeds on property.*

The citation as issued is deemed a **FINAL ORDER** determining that the violation was committed and imposing the civil fine as set forth in the citation, plus all charges and fees incurred by the City in connection with the enforcement of the applicable ordinances, including abatement costs. The person to whom the citation was issued shall be deemed to have waived the right to appeal the Final Order to Campbell District Court.


