The person to whom the citation was issued shall be deemed to have waived the right to appeal the Final Order to Campbell District Court.

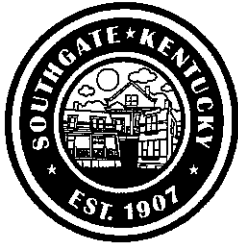
