Violations noted in citation sent: * Outside Storage & Discarded Items – remove tarp, boxes, lawn mower, exterior storage, discarded chairs & basketball hoop from side yard, rear yard, driveway and rear porch. All storage items must be kept in an enclosed structure. * Soffit - repair or replace all missing soffit material. * Porch Ceiling and roof structure - repair or replace dilapidated porch trim, ceiling and soffit material. * Paint - paint porch ceiling, gable and trim and where paint is peeling, faded, chipping or water stained. * Grass/Weeds - cut and maintain grass and weeds at property. * Trash / Rubbish - all trash and rubbish must be kept in garbage containers with lids. Date of citation 12/18/2021.

The person or company to whom the referenced civil citation was issued, having failed to respond to the citation within seven (7) days, as required by KRS 65.8828 and Southgate Code of Ordinances 32.57, is hereby deemed to have waived the right to a hearing, and the determination that a violation was committed is considered final. The citation as issued is deemed a **FINAL ORDER** determining that the violation was committed and imposing the civil fine as set forth in the citation, plus all charges and fees incurred by the City in connection with the enforcement of the applicable ordinances, including abatement costs. The person to whom the citation was issued shall be deemed to have waived the right to appeal the Final Order to Campbell District Court.
