If the Board determines that a violation has been committed, an order may be issued upholding the Citation, and the Board may impose a fine up \$50.00 per day per violation, up to a maximum of \$10,000.00 per Citation, or require you to remedy a continuing violation to avoid a fine, or both.

On 1/25/2019 the City of Southgate issued you a Notice of Violation. This notice required you to correct all noted violations within a specified time period. Please remember that you are still required to correct any and all outstanding violations. The City shall conduct a re-inspection of the property on 2/21/2019. Any action taken by the City of Southgate to abate the violations shall be charged against the real estate upon which the structure is located and a lien shall be placed upon such real estate.

If you wish to appeal this Citation, you may submit an application for appeal within seven (7) calendar days from the date of this notice. Applications may be picked up and submitted to the City Clerk's office at 122 Electric Avenue, Southgate, KY, 41071 or obtained from the website at www.southgateky.org.

Waste and recyclable containers shall be stored in the rear yard. However, containers may be stored in the side yard behind the front line of the house. In no case shall containers be stored in the front yard.
