Violations Noted in Citation Sent:

- *Retaining Wall – repair and/or replace dilapidated / failing retaining wall in rear yard.*
- *Exterior wall at rear porch – repair and/or replace dilapidated exterior masonry wall at rear porch.*

The person or company to whom the referenced civil citation was issued, having failed to respond to the citation within seven (7) days, as required by KRS 65.8828 and Southgate Code of Ordinances § 32.57, is hereby deemed to have waived the right to a hearing, and the determination that a violation was committed is considered final. The person to whom the citation was issued shall be deemed to have waived the right to appeal the Final Order to Campbell District Court.
