
- Retaining Wall – repair and/or replace dilapidated / failing retaining wall in rear yard.
- Exterior wall at rear porch – repair and/or replace dilapidated exterior masonry wall at rear porch.

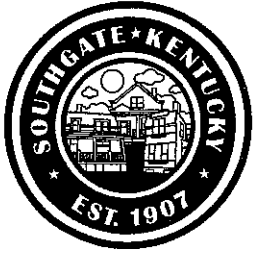

The citation as issued is deemed a **FINAL ORDER** determining that the violation was committed and imposing the civil fine as set forth in the citation, plus all charges and fees incurred by the City in connection with the enforcement of the applicable ordinances, including abatement costs. The person to whom the citation was issued shall be deemed to have waived the right to appeal the Final Order to Campbell District Court.


