**Violations noted in citation sent:** Porch – repair or replace all loose or dilapidated building material at porch, porch ceiling /soffits & gutters. Paint areas of porch and trim where the paint is peeling, chipping, flaking, or faded. (Date of citation 12/8/2021)

The person or company to whom the referenced civil citation was issued, having failed to respond to the citation within seven (7) days, as required by KRS 65.8828 and Southgate Code of Ordinances 32.57, is hereby deemed to have waived the right to a hearing, and the determination that a violation was committed is considered final.
