On 4/19/2019 the City of Southgate issued you a Notice of Violation. On 6/27/2019 the City issued you a Citation. Kentucky LANGER OF THE PROPERTY OF THE PROPERT

304.8 Decorative features. All cornices, belt courses, corbels, terra cotta trim, wall facings and similar decorative features shall be maintained in good repair with proper anchorage and in a safe condition.

302.1 Sanitation. All exterior property and premises shall be maintained in a clean, safe and sanitary condition and all outdoor storage shall be removed. The occupant shall keep that part of the exterior property which such occupant occupies or controls in a clean and sanitary condition.
