Violations noted in citation sent: Outside Storage / Rubbish – remove all construction material, construction scrap, storage, and rubbish from driveway and yard. All storage must be kept in an enclosed structure or removed from the property. Rubbish must be kept in garbage containers with lids or removed from the property. Date of Citation: 10/16/2019

The person or company to whom the referenced civil citation was issued, having failed to respond to the citation within seven (7) days, as required by KRS 65.8828 and Southgate Code of Ordinances § 32.57, is hereby deemed to have waived the right to a hearing, and the determination that a violation was committed is considered final. The citation as issued is deemed a **FINAL ORDER** determining that the violation was committed and imposing the civil fine as set forth in the citation, plus all charges and fees incurred by the City in connection with the enforcement of the applicable ordinances, including abatement costs. The person to whom the citation was issued shall be deemed to have waived the right to appeal the Final Order to Campbell District Court.
