
- *Outside Storage – remove all outside storage, construction material and scaffolding from yard and driveway. All storage items must be kept in an enclosed structure or removed from the property.*

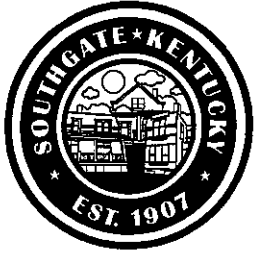

The person to whom the citation was issued shall be deemed to have waived the right to appeal the Final Order to Campbell District Court.
