**Violations noted in citation sent:** \* Outside Storage, discarded Items, trash or rubbish – All discarded items and storage must be kept in an enclosed structure or removed from the property. All trash and rubbish must be kept in trash containers with lids or removed from the property. Final Order for citation dated 1/27/2021.

The person or company to whom the referenced civil citation was issued, having failed to respond to the citation within seven (7) days, as required by KRS 65.8828 and Southgate Code of Ordinances 32.57, is hereby deemed to have waived the right to a hearing, and the determination that a violation was committed is considered final.
