
- Exterior walls, trim, siding and roof - complete work on repairs and replacement of all unfinished /
- exposed surfaces of house and roof.

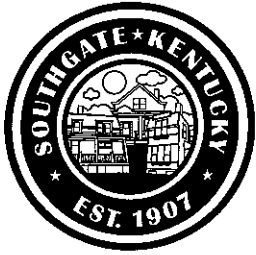

The person to whom the citation was issued shall be deemed to have waived the right to appeal the Final Order to Campbell District Court.
