- Wood Steps - repair, replace or remove dilapidated wood steps.
- Steps, Paint/Stain – paint or stain steps, landing, handrails and guardrails.

The person to whom the citation was issued shall be deemed to have waived the right to appeal the Final Order to Campbell District Court.
