

Violations Noted in Citation Sent:


- *Roof structure at rear door – repair dilapidated roof structure at rear door. Make any necessary structural repair to roof framing and sheathing. Repair or replace roof covering / shingles.*
- *Roof soffit – repair dilapidated roof soffit . Make all necessary repairs to loose and dilapidated wood soffit.*

The person or company to whom the referenced civil citation was issued, having failed to respond to the citation within seven (7) days, as required by KRS 65.8828 and Southgate Code of Ordinances § 32.57, is hereby deemed to have waived the right to a hearing, and the determination that a violation was committed is considered final. The citation as issued is deemed a **FINAL ORDER** determining that the violation was committed and imposing the civil fine as set forth in the citation, plus all charges and fees incurred by the City in connection with the enforcement of the applicable ordinances, including abatement costs. The person to whom the citation was issued shall be deemed to have waived the right to appeal the Final Order to Campbell District Court.
