**Violations noted in citation sent:** Outside storage / Discarded materials – discontinue storing skids in driveway. All storage must be kept in an enclosed structure or removed from the property, all trash and discarded materials must be removed from the property. Failure to abate this violation by the re-inspection date will result in fines of \$50.00 per day. All unpaid citations will be added to the property tax bill.

The person or company to whom the referenced civil citation was issued, having failed to respond to the citation within seven (7) days, as required by KRS 65.8828 and Southgate Code of Ordinances 32.57, is hereby deemed to have waived the right to a hearing, and the determination that a violation was committed is considered final. The citation as issued is deemed a **FINAL ORDER** determining that the violation was committed and imposing the civil fine as set forth in the citation, plus all charges and fees incurred by the City in connection with the enforcement of the applicable ordinances, including abatement costs. The person to whom the citation was issued shall be deemed to have waived the right to appeal the Final Order to Campbell District Court.
