Call to Order: Mayor Hamberg called the meeting to order.

The following answered roll call: Council Members Anderson, Melville, Messmer, Okura, Lycans, and Wegener were present. Also present: City Clerk Barton, Finance Director/Treasurer Edgley, Police Sergeant Johns, Public Works Foreman Bowman, Fire Chief Beatsch, and City Attorney Stewart.

Approval of regular meeting minutes 4/17/24. Motion/Second: Okura/Wegener. Approved by vote: Aye 6 Nay 0.

Public Works: Councilman Melville said Riegler Blacktop has started the street project at the Public Works/Auxiliary parking lot. Mr. Melville said Riegler quoted a price to repave the tennis court parking lot and Shaler alley. This would be an addendum to the contract. The Land & Water Conservation Fund Grant application stated the parking lot would be repaved. Mayor Hamberg said we can add approximately \$22,300 as a change order to the contract. This would be included in the loan with KLC for the street projects. Motion to do lease agreement for financing with KLC for up to a maximum of \$530,000 for the street projects. Motion/Second: Melville/Wegener. Approved by vote: Aye 6 Nay 0. Public Works Foreman Bowman had no report.

Public Safety: Councilman Anderson said the committee has not been able to meet to discuss the golf cart ordinance. Police Sergeant Johns had no report. Fire Chief John Beatsch said the Southgate Fire Department will have a Fire Olympics at the Community Center on May 11 at 1:00.

Code Enforcement: Councilman Messmer had no report.

Community Relations & Recreation: Council Member Okura said the Optimist Club will have the Fishing Derby on 5/18. The Park & Tree Board will have a Volunteer Garden Day on 5/2.
