Southgate is on the move!

On February 7th, Southgate City Council approved the Sunrock Development by a vote of 4 to 1 which is slated for construction by Grand Communities, a subsidiary of Fischer Homes. This development will begin near the intersection of Fox Chase and Woodland Hills Drive off of Moock Road and traverse to the top of the hill constructing the Sunrock development near and parallel to I-471 south.

Sunrock will be a multi-use development consisting of for sale townhomes, condominiums, upscale single-family homes and a Class A apartment complex. Sunrock consists of 85.8 acres with Grand Communities agreeing to build 575 units of the described home types versus the over 700 which could have been considered for this site. Included within this site will be walking trails and a Homeowners Association who will be in charge of landscaping and maintenance of the entire property. Southgate will own the streets with exception to those entering and exiting the apartment complex.

The entire project at its completion is set to cost \$120,000,000 based on 2023 dollars and have a 7-9 year build timeline. With a 10% Industrial Revenue Bond, Southgate will gain an estimated \$46,000,000 in tax revenue over 40 years.

Memorial Pointe is now well under construction with upscale single-family homes by Fischer; condominiums by Ashley; a Class A luxury apartment complex called "Vicinity" being built by

I would like to explain the Mayor/Council form of government based on the current Kentucky Revised Statutes. This is the type of government that Southgate has. As you may be aware, Southgate does not have a City Administrator or City Manager as other surrounding cities have for their administration. Typically, the Mayor may take on this role if he or she has time. This is the case today in Southgate. So as Mayor, I sit in on all inside and outside meetings which may benefit Southgate. I serve on various boards to be sure we are receiving all the information for our City. I attend meetings locally and in Frankfort as well as meet with various entities and other local elected and non-elected officials learn of ideas, benefits and possible new efficiencies for reducing costs for Public Works, Safety, (continued on page 2)

Administration, etc. Once information is gathered, it is the Mayor's job to present matters to Council for consideration. Under Kentucky's laws governing meetings, with only a few exceptions, all matters of public concern must be considered by Council in open session. This can be tough when the matters also have time constraints and require quick decision by Council. However, ultimately, it is up to Council (not the Mayor) to make decisions based upon the facts presented and on what each council member interprets as being in the best interest of the City. The Mayor/Council form of government functions like the Executive Branch of the federal government where the Mayor acts in that capacity and Council acts in the capacity of the House of Representatives or Senate. The mayor is the Executive branch, and the City Council is the Legislative branch. Under the Kentucky Revised Statutes, a mayor has no vote in any matter unless there is a tie vote. The only exception to this lies with zoning map amendments. Mayors in our form of government cannot break a tie in a zoning matter because the mayor is not part of the legislative body and a zone change is, by statute, a decision of the legislative body only.

-As always, if you see a potential problem or need the police, don't hesitate to call us at 859-292-3622 this is the number to police dispatch. The dispatcher can send an officer to you or have them call you directly 24 hours a day. In an emergency always call 911. If you simply need to talk with someone in a non- emergency, feel free to call the police department direct line at 859-441-7473.



-Summer is fast approaching so please be cautious while driving through our city. Kids will be out playing and the police will be out watching your speed and stop signs.

-As you complete your spring cleaning, don't forget that we have a drug take back box at the city building. Any old, outdated or no longer needed prescription drugs can be dropped into the box. These pills will be destroyed so they do not end up in the hands of those that should not have them. The drug drop box is available during the city office business hours of M-F.

-You can sign up for alerts from the Southgate Police Department (and other public safety agencies in our area) simply by visiting our city website and clicking on the police department link. There you will find the signup for Nixle alerts. Nixle is a free program that can help you stay informed of safety issues as well as community related events in our area.

-Finally, this is a reminder to lock your doors of your vehicles and your homes. Please call the police if you see something suspicious in your neighborhood. Being a good neighbor is sometimes as simple as looking out for each other!

Park News

The City of Southgate received a Land Water Conservation grant to demolish the tennis courts at Electric Ave. and Evergreen Ave. that had become unsafe to use because of the cracks in the pavement. Our Public Works Department worked hard to remove the old black top and fencing to make way for a new green space park. The area has been cleared and grass seed has been planted. Soon it will be ready for play!

New playground equipment was purchased for the Southgate Community Center Park at 301 W. Walnut St. Public Works is working on this currently. Completion to be determined dependent on weather this Spring/Summer. This will be a great addition to the park!

Duke Energy Foundation has awarded the City of Southgate funds to purchase 3 new park benches for the Southgate Community Center Park. These will be placed around the park and walking trails. These benches will be installed by this summer.

Did you know that KY Dept. of Fish & Wildlife stocks the Community Center Lake with trout and catfish each year? Fishermen are welcome, but remember to get your license first.

Nixle is a Free emergency notification system that provides secure and reliable communications from local Public Safety Agencies. It is dedicated to keeping you up-to-date with important information that's immediately delivered to you. It is most commonly used by police and fire departments to share information about public safety and emergency issues. The Southgate Police Department administers all Nixle alerts for the City of Southgate. The service is free and there is never any spam or advertisements.

Emergency alerts from the Southgate Police Department will always be sent via text message or email.

Community and Advisory Messages will only be sent via email.

You can elect to receive emergency alerts, or community messages, or both. Sign up at Nixle.com or go to the City website on the police page to sign up.

North American Properties of Cincinnati; and an 89 bed senior facility owned by Arcadia with planned construction beginning in 2025. The completed estimate for the Memorial Pointe development will be \$65,000,000 based on 2022 dollars. Southgate City Council approved an Industrial Revenue Bond for the apartment complex only for 30 years in 2022 insuring a quality development being built by a quality Cincinnati based developer in North American Properties.

The Memorial Pointe development is not even halfway complete and is already providing additional tax revenue to Southgate that have exceeded initial expectations, since the overall value of the completed properties has increased by nearly \$4,000,000 over original estimates. It is anticipated Southgate will gain similar appreciation in value on the Sunrock development as construction costs will no doubt increase by the time construction begins and ends.

Needless to say, Southgate is on the move! Before these developments, Southgate was receiving approximately \$26,000 annually for the Memorial Pointe (formerly Beverly Hills) property and roughly \$1,100 for the Sunrock property as both were or are undeveloped and open ground. Southgate is excited to have these new developments within our city as both will bring more residents to Southgate while providing new sources of tax revenue for supporting safety, public works, fire and ambulance and city administration while helping to reduce taxes.
