Fact(s) Constituting Offense(s):

You were issued a Final Notice of Violation for several violations on your home dating back to 3/18/2021 on 9/11/2025. A citation for that Final Order was dated 9/2/2025 for the amount of \$4,500.00. This current citation is based on the city ordinance for fines to accrue at \$50.00 per day and it has been another 189 days since last Final Order was issued. This unfortunately is now at \$9,450.00 for this current citation.

Total Fine: \$15,450.00

You are notified that you are in violation of the above section(s) of the City of Southgate Code of Ordinances and/or the International Property Maintenance Code as adopted by the City of Southgate.

IF YOU DO NOT CONTEST THIS CITATION, you must pay the amount shown above as "Total Fine" at the Office of the City Clerk, 122 Electric Avenue, Southgate, KY 41071, **within seven (7) calendar days from the date the Citation was issued.**

IF YOU DO CONTEST THIS CITATION, you must request a hearing before the City of Southgate Code Enforcement Board **within seven (7) calendar days from the date the Citation was issued.** Appeal forms are available from and may be submitted to the Office of the City Clerk, 122 Electric Avenue, Southgate, KY 41071. If the Board determines that no violation was committed, an order dismissing the Citation shall be entered. If the Board determines that a violation has been committed, an order may be issued upholding the Citation, and the Board may impose a fine up \$50.00 per day per violation, up to a maximum of \$10,000.00 per Citation, or require you to remedy a continuing violation to avoid a fine, or both.

IF YOU FAIL TO PAY THE CIVIL FINE SET FORTH IN THIS CITATION OR CONTEST THE CITATION WITHIN THE TIME ALLOWED, you shall be deemed to have waived the right to a hearing before the Code Enforcement Board to contest the citation; the determination that the violation was committed shall be final; the citation as issued shall be deemed a Final Order determining that the violation was committed and imposing the civil fine as set forth in this Citation; and you shall be deemed to have waived the right to appeal the final order to Campbell District Court.

BECKER MARY CATHLEEN :

On 08/11/2021 the City of Southgate issued you a Notice of Violation. This notice required you to correct all noted violations within a specified time period. A re-inspection of the property was conducted on 3/19/2026. The following violations were not corrected as required or have occurred again (see attached code sections and/or photographs for details):

Fact(s) Constituting Offense(s): The city issued you a Final Notice of Violation on 8/11/2021 and also the most recent Citation on 9/02/2025 for \$4,500.00. A Final Order for that Citation was sent to you on 9/11/2025. Nothing has been done to correct any of the violations noted in your citations previously. As of 3/17/2026 the situation has been made worse by the rear porch ceiling falling down onto the rear porch. We have exhausted all means to have you attempt to fix the violations of your home for siding, non-operable windows, damaged rear porch ceiling, and junk around your property. It has been 189 days since the last Final Order was sent to you, therefore, at the City Ordinance of \$50 a day fine the new issued citation is for the amount of \$9,450.00.

304.6 Exterior walls

304.6 Exterior walls. All exterior walls shall be free from holes, breaks, and loose or rotting materials; and maintained weatherproof and properly surface coated where required to prevent deterioration.

Therefore, the City has issued a Citation for the violations that were not corrected. Attached for your review is the Citation. **Please submit payment for the amount listed under Total Fine. The fine must be paid within seven (7) calendar days of the date of the Citation. If you fail to respond, you shall be deemed to have waived the right to a hearing before the Code Enforcement Board to contest the citation; the determination that the violation was committed shall be final; the citation as issued shall be deemed a final order determining that the violation was committed and imposing the civil fine as set forth in this Citation; and you shall be deemed to have waived the right to appeal the final order to Campbell District Court. Please remember that you are still required to correct any and all outstanding violations. The City shall conduct a re-inspection of the property on 05/28/2026. If any violations remain, additional Citations may be issued. The City may also pursue enforcement and resolution through appropriate legal action. *Any action taken by the City of Southgate to abate the violations shall be charged against the real estate upon which the structure is located and a lien shall be placed upon such real estate.*

If you wish to appeal this Citation, you may submit an application for appeal within seven (7) calendar days from the date of this notice. Applications may be picked up and submitted to the City Clerk's office at 122 Electric Avenue, Southgate, KY, 41071 or obtained from the website at www.southgateky.org.
